Mayor defends Land Bank loan

THE MAYOR IS STANDING tion of the costs was donated firm in his decision to borrow money from the Land Bank amidst criticisms from former government officials who said that the projects to be financed were not "necessary". The projects are: renovation of the municipal building, construction of a dormitory at the third floor of the public market, construction of a convention center at the fourth floor of the public market, air-conditioning of the municipal gymnasium, purchase of heavy equipments and purchase of vehicles for members of the Sangguniang Bayan.

The amount of the loan is projected to be in the vicinity of 40 million pesos, the biggest ever to be borrowed by the municipal government.

Mayor Dolor said the municipal hall is in dire need of repair as termites have done considerable damage to the building. In the Annual Investment Plan (AIP), the Mayor also approved the construction of a second floor at the right and left wings of the municipal hall. The municipal hall was the product of 3 of the Mayor's predecessors: Mayor Pablo Lineses, Mayor Goring Delgado and Mayor Teo Atienza. Income-generating

In an interview, the Mayor strongly said that the dormitory and the convention hall would be income-generating and could pay for the loan as well as earn additional income for the municipality. The Mayor explained that the convention center can house 700 people and can be subdivided into smaller sec-

"So if only 100 people will use it, the other sections will be closed."

The Mayor also scribbled notes on how they plan to sell the beds of the dormitory, saying that the small investment that will be needed to finance the project can be paid for in a short period of time.

The air-conditioning of the gymnasium, the Mayor said, will showcase Puerto Galera as one of the most progressive towns in Oriental Mindoro. He added that the gymnasium will be rented out to any interested organization who may want to use it.

purchase heavy equipments for it to provide basic services like garbage collection and road repairs. He said that almost all the equipments that he inherited from the past Mayor are no longer in good working condition.

The Mayor, however, relented on the purchase of vehicles for members of the town council. He said that they might not include this anymore in the loan negotiations with the Land Bank. He said that this might just be appropriated in the budget for next year to be taken from the general fund.

Councilor Virleo Persia said that the vehicles will be "second hand" and will be assigned to each councilor so they can go to the barangays and attend to the needs of their constituents. However, 4 of the 10-member town council had stated that they oppose the purchase of the vehicles.

Water rehab agreement to be finalized

that the Memorandum of Agreement (MOA) with the Puerto Galera Water Consortium (PGWC) on the rehabilitation and expansion of the water system will soon be finalized.

Municipal officials are stepping up preparations for the launching of the project on August 8 with a formal ceremony at Barangay Aninuan followed by a motorcade to San Isidro, Balatero, Poblacion, Palangan, Sinandigan.

The Mayor said that the Technical Working Group is reviewing the fourth draft of the MOA and once finalized the MOA will be sent to the Sangguniang Bayan for their approval. The MOA had undergone several revisions which Sinandigan so that they will

The Mayor said that that was a "piecemeal" solution and that the municipality needs a holistic approach to the water supply problem. The Mayor added that the municipality cannot on its own undertake the project and that the MOA is very advantageous to Puerto Galera.

When asked if the Agreement will mean an increase in water tariff, the Mayor replied that the matter will be decided by the Sangguniang Bayan and not the "private partner" as earlier reported.

Iraya Mangyans now own **5700** hectares of PG land

THE PROVINCIAL DIRECTOR the territory or natural habitat farm implements and financial of the National Commission of Indigenous Peoples (NCIP) told the Sangguniang Bayan last July 15 that the Iraya Mangyans, the indigenous cultural minority of Puerto Galera now own more than 5700 hectares of land, making them the biggest landowner in the municipality.

The NCIP is helping the Mangyans get the Certificate of Ancestral Domain Title (CADT) from the Registry of Deeds.

In the NCIP website, the land was awarded to 2888 individual beneficiaries.

Reynante Luna of the NCIP said that his agency is also helping the Mangyans make a sustainable development plan for their land called ADSDPP or Ancestral Domain Sustainable Development and Protection

of the Iraya Mangyan.

ADSDPP is important because it spells out the plan of the Mangyans for their newly acquired land.

The Mangyan land covers all the way to Villaflor.

It is prohibited to go to the Mangyan land without first getting the permission from the tribal leaders or the Ambuyan, Mangyan priest.

However, in their development plan the Mangyans would like to develop parts of their land as tourist destinations. They also plan to build a Mangyan Cultural Center where handicrafts can be seen and sold.

The Mangyans also plan to develop large tract of their property for agriculture and are seeking the assistance of the government to provide them new Ancestral Domain refers to farming technology, seedlings,

assistance.

Meanwhile, environmentalists are concerned that the last remaining rainforest will be affected by the land grant.

Some Mangyans employ the the boondocks from Talipanan slash and burn technique (kaingin system) when clearing the land for planting. The kainigin is worst than illegal logging as it destroys everything.

> In their ADSDPP, the Mangyan said that kaingin is only allowed when the Ambuyan has found the land to be suitable for farming and should not be near watershed

The Mangyans also said that they will have forest rangers (bantay-gubat) to prevent illegal logging activities.

Most of the illegal logging are done by Mangyans who deliver the logs to the lowlanders who ordered them.

San Isidro and Aninuan. The Mayor added that it is in the private partner's interest to see that more households get connected and all the leaks are taken care of as the private partner's return on investment is dependent on the revenues from the water bills.

PG Adopted Son rises to the occasion after Senate bashing

"THERE IS ANOTHER Hubbert aside from the Mayor that we should be talking about" says one resident to me a few days ago.

"And who is that," I inquired.

"Hubert D'Aboville!"

"Ah, yes, Mr. D'Aboville. Is it because he was the one who worked hard to give us the coveted title of being one of the most beautiful bays in the world?"

"Not really."

My friend told me that D'Aboville's most recent coup was when he rose to the occasion after our senators reprimanded him and other officials of the Joint Foreign Chambers of Commerce (JFC) in a senate hearing last June 6. Earlier the JFC, where D'Aboville sits as the spokesman, wrote a letter to President Arroyo asking her not to touch the EPIRA law, to do so, the JFC said would dampen more foreign investments to the country. Under the EPIRA law, foreign corporations are able to buy NAPOCOR's assets and our "patriotic" senators would like the NAPOCOR to remain under the government's con-

Consequently, the senators didn't like the JFC's letter and they took turn in bashing Mr. D'Aboville et al.

Senator Juan Ponce Enrile told D'Aboville to "get out of this country if you can't live with us." And when D'Aboville tried to read the statement of the JFC, Senator Miriam Santiago cut him short and said, "You may not continue. You do not determine what you can say or not say, I determine."

D'Aboville and the other officials of JFC kept their cool and prudently apologized for the letter sent to the President which the senators claimed should have been sent to them instead.

The senate hearing was televised and major TV networks showed the dressing-down of the foreign investors in primetime news. Commentaries

and editorials from all major newspapers were critical of the senators for their attitude towards the JFC. A few days later, President Arroyo—possibly having been informed that several European ambassadors were prepared to file a formal diplomatic protest—came out with a statement thanking foreign investors for being part of the country's "success".

D'Aboville whom reporters later interviewed said that he was not "necessarily offended" by Senator Enrile, and that he would be willing to stay "for the next 30 years."

"Many of us have been here in the Philippines not because we are forced to be here, but because we like it here, because we love it," he said.

"I am a living testament of these happy foreign expats, having lived in the Philippines for nearly 30 years and being happily married to a Filipina who is a granddaughter of national hero Dr. Pio Valenzuela."

"My wife and I have been blessed with four Filipino-French children who can speak Tagalog fluently. Furthermore, after having built our house and farm in Puerto Galera 13 years ago, I am proud to be named an adopted son of Puerto Galera after our Puerto Galera Bay became a certified member of the Club of the Most Beautiful Bays in the World through my humble personal initiative."

But when prodded about his reaction to Enrile's outbursts, he said: "I have never heard anything like this before, as far as I am concerned."

D'Aboville wrote a column in Business Mirror and said: Like any human being, "foreigners also appreciate being treated with civility and respect as guest, with the understanding that it is our genuine interest to see the Philippines succeed and prosper because our business depends on it."

He added: "Last year, foreign direct investments to the country were at a two-year high of \$2.9 billion, with the biggest chunk coming from Europe... There is no doubt that what the country is getting now is just a drop in the bucket."

The Philippines is lagging behind other ASEAN countries in terms of foreign direct investments. Last year Vietnam attracted \$15 billion while Singapore got \$36.9 billion. D'Aboville believes the country can get "as much as \$10 billion annually in the years to come provided that barriers and bottlenecks in the administrative and legislative sectors and the Constitution are addressed."

"We need a road map. We need the government to show us the direction it wants to take. We also need a competitive and stable business environment."

Thank you Mr. D'Aboville for those kind words; you gave us another reason why we should not vote for Enrile or Santiago. Also, what you said does not only apply in the national sphere, they are also true even in our small town of Puerto Galera.

We need to attract more foreign investments and the Mayor as well as the members of the town council should try and get inputs from Mr. D'Aboville on how to do this. More investments mean more jobs and better economy.

Puerto Galera is so blessed not only with the natural resources but also with our multicultural human resources. It is high time that the community acknowledges the many great things we got from the foreign investors and make them feel "they belong" instead of just being "guests" in our municipality.

Mr. D'Aboville is the president of the country's European Chamber of Commerce and is also the president of the Puerto Galera Most Beautiful Bay Club. He comes home to a sprawling Puerto Galera property which he calls a farm house. Next time you meet him say "hi" to the guy that made Senator Enrile really look bad.

Ordinance vs loud bikes needed

IT'S hard to understand why our town operated in this state." and provincial legislators remain deaf to the growing clamor by majority of their constituents to enact ordinances against loud motorcycles that produce nerve-wracking noise even in the late hours of the night not just along major roads but also along quiet neighborhood streets.

In some parts of Metro Manila, namely Makati and Marikina, ordinances against the use of loud noise producing open or free flow pipes for motorcycles is being prohibited.

Our councilors should enact an ordinance aganist the nauseating noise being produced by the "modified" motorcycles, particularly the barebones, scooters and other mini-motorcycles.

The new leadership of the Land Transportation Office (LTO) has issued its own guidelines in operation of motorcycle on roads and highways for the benefit of the general public. Among these is the prohibition of modifying any part of the original design of a motorcycle or scooter without approval from the agency and the Department of Trade and Industry.

The LTO must have noticed that many motorcycle riders modify their stock exhaust pipes with much louder open or free flow pipes. The agency has imposed a P2,000 penalty for violators of this rule. But since the LTO has very few field staffs, local government officials must still do their

Ordinances and rules against the fast growing number of loud motorcycles should be enacted by municipal governments to ensure effective implementation of the law.

Our councilors can pattern the ordinance after motorcycle level standards being implemented in the United States.

In the State of Arizona, for instance, rules for motorcycle riders are very clear: "A person shall not operate or as an owner permit the operation of a motorcycle in this state that is not equipped with the Manufacturer's Original Muffler Or Other Original Noise Reduction Equipment or with a replacement muffler or replacement noise reduction equipment capable of reducing the noise levels below pass or similar device on a motorcycle of irritating loud motorbikes.

Because of the public's clamor, state and local legislatures in America, still enact laws against loud motorcycles although under current federal noise statutes, it is illegal to modify an exhaust system to increase noise.

In Boulder County, Colorado, for example, has a law stating: "No person shall operate anywhere in unincorporated Boulder County any vehicle having a muffler that has been equipped or modified with a cutoff, bypass, or any similar device or modification."

All the measures against the use of open and free flow pipes by motorcycle owners inside and outside our country have only a single purpose - to reduce noise, which is defined as "any sound which annoys or disturbs humans or which causes or tends to cause an adverse psychological or physiological effect on humans."

Resort owners in the Sabang area along the main road to Poblacion have been complaining to officials regarding the loud noise generated by the motorbikes. One resort owner even had to give a discount to a group of divers when they threatened to file a suit against the resort for the discomfort caused by the loud motorbikes.

Mermaid Resort had to install thick glasses on their windows to ensure their guests will not be bothered by the noise.

Many residents residing along the road especially where there are habal-habal bikes had been clamoring for regulations not to disallow bikes but to disallow modification of the bikes to produce those terrible roaring noise.

The barangays can also make a barangay ordinance prohibiting loud bikes and collect penalty payments for those violating the ordinance.

"It is very disturbing. I can't even sit on my porch without having to hear someone blasting by and making sure they goose the throttle to make more noise," said one resident. "Anyone who invests more money to make a motorcycle louder just hasn't grown up yet. Most of these guys are older, I can see them riding by. I am not saying don't ride a motorcycle, just tone it down.'

Sabang jetty pier

Now that the municipality has passed the 4 points of entry ordinance, it is high time that the government develop a jetty pier in Sabang if only to ensure the safety and convenience of the riding public.

Ferry passengers have to hop into a dinghy especially during low tide to board an outrigger ferry or disembark from it. It is dangerous and very inconvenient as sometimes one needs to take off the shoes so as not to slip from the slippery deck or get wet from the waves.

It will also be a great investment for the government as passengers will willingly pay for the use of the jetty pier.

Fare hike for trikes

The Tricycle Franchising and Regulatory Committee (TFRC) of the Sangguniang Bayan (SB) has approved the proposed fare increse of the Puerto Galera Tricycle Operators and Drivers Association (PGTODA). Following the rising cost of gasoline and other basic commodities, the PGTODA proposed an increase between 2 to as high as 5 pesos per route of the tricycles. That means if one pays 6 pesos from Sto. Nino to Poblacion, he/she now pays 8 pesos for the regular trip. A regular trip means 4 passengers in a tricycle.

The TFRC should enjoin the drivers to post the fare matrix inside the tricycles for the passenger's information. The SB can also give tax rebates so that the PGTODA will not again ask for a fare hike once prices petroleum products begin to go up again.

Consumers group needed

While attending the public hearing on the fare hike for tricycles, I noticed that almost all those who attended are drivers and/or owners of tricycles. Almost all the questions came from the tricycle association except for one senior citizen who complained that the drivers are ignoring her because of the mandatory discount given to senior citizens. Another exception was from a foreign resident who pointed out clerical mistakes in the fare matrix.

Clearly missing was the concerns of riding public, the voice of the consumers. That is what is lacking in Puerto Galera, no consumer group to object to fare hikes or advance to the authorities the concerns of the consumers.

The jeepneys also increased their tariff. Now its 90 pesos when before it was 70 for the trip to Calapan. The ferries also increased the price of the ticket from 180 to 230 and now to 250.

In all these, the riding public had remained a passive observer, a mere spectator, a dumb victim? Someone should push for the organization of a Consumer Group NOW.

Mining in Dulangan

Gold mining is now undoubtedly the biggest industry in Dulangan and Tabinay with more than 500 employed. Many of the miners are not from Puerto Galera coming from as far as Benguet or Abra. Many holes had been dug, with tunnels cricrossing beneath the mountains.

The government allows small-scale mining with minimal requirements. Some residents however feel that there should be health and environment seminars for the miners to make the industry sustainable.

Whale shark sighting

Last July 15, Dulangan residents saw a whale shark near the shore along Varadero Bay. News spread quickly and later some divers swam with the butanding.

The butanding left after several hours. Whale sharks are migratory animals, they travel from 1 feeding ground to another, traveling hundreds of miles. One famous butanding area is Donsol, now frequented by thousands of tourist for the opportunity to swim with the butandings.

Muelle Hotspot

Good news for Internet users in the Muelle pier area. Joonee of Krisnee Internet Cafe had just installed a powerful antenna which provides Internet access within Muelle pier and surrounding area. Joonee said that most of his customers are yachtees who can browse the net while on board their yacht 500 meters away. He added that they now sell prepaid Internet access.

New adopted son

Hans Jorgen Nielsen is the latest foreign resident to become an adopted son. Nielsen donated used computers worth nearly 5000 US dollars to the Municipal High School. In a ceremony at the High School, Mayor Hubbert Dolor and school officials heaped praises to Nielsen and Ex-Councilor Danny Enriquez read the ordinance making him an adopted son of Puerto Galera.

Enriquez who sponsored the ordinance said Nielsen promised to give more help to Puerto Galera schools.

There are many more foreign residents who the Sangguniang Bayan should recognize. There others who contributed more than what Nielsen has given but who has remained unrecognized. There contributions will amount to thousands of US dollars in terms of promotions, community projects and donations to social events over many, many years. I hope the SB will not be miserly in granting due recognition to them.

Another SWTP solution

just spoke Ms Aileen Bareng, head of the tourism office and she said that tourism arrival last year was in the vicinity of 1.7 million. I agree that this figure must be somewhat too high as we estimate that maximum tourist arrival would be around 700,000 to 800,000 - given present capacity. Now the thing that baffles the mind is that it is almost one-half year since they started collecting the EUF (they started December) and as of May, they have only collected 6 million pesos which translates to 120,000 tourists. Hmmmm, peak season is almost over and the question is: why only 120,000 at this point in time???

KiddoKalaw: The figure of 120,000 tourists annually is not a surprise to most in the business community. Factor in the number of rooms in Puerto Galera and the number of trips from Batangas and occupancy rates and you get a figure of 300,000-500,000. (Note: Boracay has just over 500,000 annually) I have always wondered what the basis was for tourist arrival numbers given by the Tourism Office. This astronomically, exponentially, erroneous number seems to have ignited a raging inferno of self interest on the unrealistic expectation of collecting 50-100 million annually from the EUF.

netmagus: I do not wish to cast aspersions but the govt should explain why they are declaring 6 million pesos as of May, when it should be more if we based it on estimates of the past coming from the govt. Are there that many tourists able to evade collection agents at the seen so many bright ideas that

KiddoKalaw: Obviously, the LGU estimates are wrong. And yes, collection is not 100%. Also a system of controls for the monitoring of collections at the source should be put in place. This function is given to the Local Chief Executive, not the CRMB, as per the Ordinance

netmagus: Next question is: why is the CRM Board not meeting, why has the Mayor not called a meeting... when will he convene the Board... who replaced the members who resigned... under the ordinance the Board is the one that has authority to allocate, appropriate, disburse and make policies make the EUF work to fulfill the re: use of the EUF. What happend to the CRM Board?

KiddoKalaw: The CRM Board has met 4 times in the if not impossible, to implement past year. At the last meeting the amount of P3.5M was recommended for the purchase of land for a new dumpsite/landfill and P 2M for the road access. Contrary to public perception, the CRMB's only role in the EUF Ordinance is to recommend disbursement. The Management and Administration of the Funds is the function of the Local Chief Executive. There will be a new CRMB starting September to be appointed by the Mayor.

netmagus: We have voiced our concerns many times before and after the ordinance was passed... the SB need to review the creation, composition and powers of the Board... otherwise, politics will come into play... Alas.. WWF, the people who crafted the ordinance did not listen to the people who had

never saw the light of day.

KiddoKalaw: Politics has been in play from the start. The ordinance passed by the SB is a different version from the draft initiated by WWF and the CRMB. The Ordinance is defective and should be reviewed. Any amendments dictated by politics or self-interest will just magnify its defects.

The Willingness to pay Survey conducted by the WWF was premised on the Private Sector, through the CRMB, managing and administering the funds. This is nowhere to be found in the EUF Ordinance.

netmagus: How do we objectives for which it was cre-

KiddoKalaw: It is difficult, a defective ordinance because this usually ends up in the regional trial court for clarifications, declaratory relief...Or in the cases where legitimate business and taxpayers are affected by a defective ordinance – Temporary Restraining Orders.

It is not up to the private sector to be a "hero". The private sector has given its' support and inputs with regard to the EUF. The Local Government Code and Municipal Ordinance 04-14 have provided the legal basis for the composition and powers of the CRMB. Yet the SB passed the EUF Ordinance transferring the management and administration of the EUF Funds from the CRMB to the Mayor and the monitoring and review of the EUF to the Sangunian Bayan in total disregard of the Local government

Code, Municipal Ordinance 04-14 and the willingness to pay survey for the EUF conducted by WWF. Why?

Because of public hearings against the powers of the board. There is no logic wherein the private sector and stakeholders, who are members of the CRMB - composed of 14 persons - find themselves too powerful that they decide to let one person handle the administration and management of EUF funds.

Could it be that the astronomical, exponential, and erroneous figures on the millions of tourist arrivals have something to do with this? We don't need a hero, we just need that the SB stop being the villains. But will they? Their legislative track record is not impressive. The 1 point of entry ordinance was defective, the EUF ordinance is defective. How many other new ordinances are defective because of the so-called public hearings or in the case for major stakeholders in the tourism sector, non-public hearings?

elgalleon: Thank you Kiddo for the info. I don't understand when you said that there will be a different board. What is the new CRM and how is it gonna be different?

KiddoKalaw: The Mayor is supposed to appoint new representatives from the private sector and on the list below as our 3 year term will be over in September: Sec. 2.1. Creation of the Coastal Resources Management Board (CRMB). A Coastal Resource Management Board is Mayor disagrees with the hereby created which shall be composed of the following: (a) the municipal mayor or his/her duly authorized representative as Chairperson; (b) the chairperson of the Committee on Tourism of the Sanggunian as Vice-Chairperson; and, (c) the chairperson of the Committee on Environmental Protection of the EUF funds based on the pur-Sanggunian; (d) the Municipal Planning and Development Officer; (e) the Municipal Fisheries and Aquatic Resources Management Council

(1) non-governmental organization (NGO) representative; (g) one (1) representative from dive resort owners; (h) one (1) representative from non-dive resort owners; (i) one (1) representative from boat operators/boatmen association; (j) one (1) representative from academe/scientific community; (k) one (1) representative from the dive professionals; and (1) one (1) representative from an accredited club or organization as members. The Board shall meet at least once every two (2) months or as often as may be necessary. The members of the Board are enjoined to provide voluntary counterpart contribution in any form that would sup-

port its operation. Sec. 2.3. Term of Office. Board members shall serve for a term of three (3) years without compensation and the nature of service rendered is voluntary; Provided that whenever a vacancy occurs during the term of a member, a new member shall be appointed in the same manner as the original appointment in order to complete the unfinished term of the said vacancy.

1.What will happen to the CRMB?

This is entirely up to the SB. Probably changes in its composition. But it does not matter as the CRMB never had any real function in the EUF ordinance, as most people are led to be-

2. What is to be done if the CRMB recommendation?

This will not happen because: "The Municipal Mayor shall administer and manage all the collection, disbursement and allocation of the funds collected based on the purposes identified in this Ordinance."

1. The Mayor Allocates the poses identified in the Ordi-

2. The CRMB has no choice but to recommend the allocation as long as it is "based on the

(MFARMC) chairman; (f) one purposes identified in the Ordinance."

> 3. The SB Approves the allocation and recommendation.

The CRMB is a rubber stamp for the LGU. It is more like a clerk checking that the t's are crossed and the i's dotted. So it will never happen that the mayor will not like the recommendation of the CRMB. The CRMB can only recommend what the mayor allocates and the phrase "based on the purposes identified in the ordinance.", is so broad in the ordinance and IRR that it includes non-environmental matters.

So the EUF funds are no different from from Land Bank loans or development aid wherein the Mayor allocates and the SB approves.

kitkat: can the business groups lobby for more private sector participation in decisionmaking process especially on the allocation of funds in the amendment to the ordinance. The biggest problem is that there is no united business sector and most of the major players have given up. No corporate social responsibility among major resorts because most of them are not professional op-

Private Sector participation in decision-making process especially on the allocation of funds has been the basis for the Willingness to Pay Survey conducted by the WWF. This is nowhere in the EUF Ordinance. The problem is the SB has refused to recognize this basic premise. The LGU does not want private sector participation in the allocation and approval of EUF funds. Period.

And, I agree, most major players have given up, not because of lack of corporate social responsibility as they provide a substantial part of EUF collections remitted to the LGU, but because the former, and current, LGU has a policy of disregarding the concerns of the stakeholders/private sector/tax-

The proverbial "killing the goose that lays the golden egg" is always true in Puerto Galera, as the community and the government remain in a state of denial when it comes to the continuing, enduring, non-stop destruction of our natural assets.

the mountains. For example, a loose earth created by extensive kaingin will gradually find its way to the seashore causing siltation and killing the coral reef."

The celebrity in the group, at least in terms of popularity amongst environmentalists, is Mario Lutz, the founder of the Reptile Zoo near Ponderosa. Mario aside from his passion for reptiles also got hooked on rainforest conservation and has special interests on orchids found only in Mindoro. He has documented and photographed rare species of orchids which everybody from Puerto Galera can be truly proud of. These orchids like all the trees, reptiles, insects, birds and other living things are all in danger of extinction because of the kaingin and the illegal logging.

Boyet Galang who is the founder of the biggest cooperative in Puerto Galera is also part of the group and shared his experiences as a deputized forest ranger. He also had dealings with the Mangyan leaders and had suggested livelihood alternatives as well as new farming techniques that will help address the problems of the Mangyans.

I help the group in dissemi-

nating information and liaising with government officials and other major players in Puerto Galera.

Our group plans to hold environmental outreach programs to students, barangays officials, Mangyans, tourism establishment owners and other who wish to listen and be aware of the current state of our fragile environment as well as what could be done to protect and conserve Puerto Galera's biggest tourism assets.

Now that the primary focus of government is the rehabilitation of the water system, perhaps more attention will be given on the conservation of the watershed areas which is actually our rainforest. The rainforest acts like a sponge that collects the water. Even if millions of pesos are spent for infrastructure and nothing for conservation it would ultimately be a foolish venture.

Fortes wrote that the reasons were clearly common

"It was not designed in relation to the range of the magnitude of the impacts and direction of the waves that will eventually wash White Beach, especially in the coming years when this natural process is becoming increasing stronger and more frequent. Do they believe in global climate change?"

Fortes said: "It is very close to the water, aggravating the negative impact of the waves."

Fortes added: "The materials used were just hollow blocks! They were too, less than 2 meters, too shallow to withstand natural erosional processes."

"There are no additional

structures to support them, especially now that people are using it as a bridge and a walkway. I suggested to one barangay council member to plant native trees with good potential to hold the sand and protect the structure."

Fortes said that if people will not replenish the sand lost from getting them for construction, to the establishment of shops and putting picnic tables closest to the water, the entire sandy beach will lose its usefulness and quality


Lastly, the professor said, "Unless the people of White Beach will sustain their contribution with the support from the Municipal Government, if any, it cannot be sustained in the long-term."

Mayor wants common façade for White Beach

Mayor Hubbert Dolor wants the frontage of White Beach to have a common façade before the year is over.

The façade will be built on the walkway along the marine salvage zone.

Municipal officials are now engage in information drive to convince owners of beachfront establishments to build the façade.

The façade was designed by the Municipal Planning

Office and was meant to give a good first impression to visitors going to White Beach.

However, business owners and members of the San Isidro Business and Resort Owners Association (SIBROA) are opposed to the project.

SIBROA President Leny Del Mundo said that the design is unacceptable as it would make White Beach look like a cemetery.

She said that they are totally opposed to the project even as municipal officials assure them that the façade will beautify White Beach.

Del Mundo said that beauty is in the eye of the beholder.

"It does not mean that if you suggest to a woman to put on make up that that woman will be beautiful because of the make up," said Del Mundo who owns Mindorine Oriental, a beachfront resort.

Another SIBROA member had asked other members not to initiate the building of the

"The Mayor is asking the beachfront owners to pay for the building of the façade. Why would we pay for something that we dislike?"

Municipal Engineer Rod Manongsong said that he spoke with SIBROA officials and had told them to air their grievances directly to the

Engr. Manongsong said the Mayor wants the project done before the next renewal of business permits on January 2009.

Owners are concerned that the Mayor might again require them to build the façade like the walkway. SIBROA said that the Mayor required business owners to first build the walkway before business permits were given to them.

This time, however, SIBROA said their members are united in opposing the project and will seek legal remedies if the Mayor will again force them to undertake the project.

A White Beach resident commented that the design of seawall and the walkway were flawed according a UNESCO scientist and that the structure might not last long.

Professor Mike Fortes said that he is giving the structure 3 to 4 years and "you will see its eventual collapse."



Nagpagawa si Father ng card na may tatak ng silyo ng simbahan, para sa lahat na pamilyang tagalog, upang mabigyan na rin ng mga harina, mais, bolgor, kuaker at gatas. Iba-ibang baryo ang binibigyan ng rasyon bawat araw.

Nagpagawa si Fr. Thiel ng isang Grotto sa may likod ng simbahan sa tapat ng paaralan. Isang taga-Bongabong na kung tawagin ay Mang Dalma ang naggawa nito. Marami ang tumulong sa paghahakot ng mga bato at buhangin at nagtanim ng mga bulaklak na rosas at iba pang bulaklak sa paligid ng simbahan at Grotto. Ang grottong ito ang pinaglagyan ng mahal na Birhen ng Fatima na buhat pa sa Portugal na inilibot sa buong Pilipinas at dito ibinigay sa Puerto Galera, dahil noon ito ang bayan na lahat ay katoliko. Dumating dito sa bayan ng Puerto Galera ang mahal na Birhen ng Fatima noong May 13, 1959. Ito ang unang pagdaraos ng Pilgrimage sa bayang ito. Inihatid ng mga taga Calapan, at lahat na mga pari at mga parokyano ng Silangang Mindoro. Sa Grotto inilagay at dito rin sila nagmimisa ang mga pari kasama ang kani-kanilang parokyano. Buong hapong may nagmimisa dito. Dahil sa ito ang bayan puro katoliko, kaya pag may dumarating na ibang sekta at nabalitaan ni Father, inaalam agad niya kung saan nakatira. Pinupuntahan at pinakikiusapan ang may ari ng bahay, na paalisin na lamang sila. Noon din nagsimula na ang lahat na bahay ay nilagyan ng Ave Maria sa

taas ng pinto, tanda na ang lahat na taga Puerto Galera ay katoliko. Naglagay din ng labing-apat na estasyon o Daan ng Krus sa labas ng simbahan buhat sa lugar ng Museum paikot sa baba ng simbahan malapit sa dagat paakyat sa may grotto ng Fatima patuloy sa baba ng paaralan ng PGA at natatapos sa tapat ng malaking puno ng mangga, at doon nakalagay ang ikalaginglimang estasyon sa may puno ng chico.

Taong 1959 bago pumunta si Father sa Germay, pinag-aral niya si Maximo sa "carpentry shop" ni Brother Richard at Brother Wonirabot sa Christ the King. May araw na sa Philippine College of Art and Trade naman siya pumapasok. Pagkatapos niya, sa Rattan Craft sa Valdez Factory sa Angeles, Pampanga siya pumapasok. Dalawang taon din siyang palipat lipat sa tatlong lugar na ito. Nang sya ay bumalik na dito naganyaya si Father ng gustong mag-aral at may hilig rin sa carpentry at tuturuan sila ni Maximo at sina Sancho Ceniza, Rolando Axalan, Panchito Torcuator, Efren Balita, Antonio Persia, Danilo Lineses at Pablito Lalongisip at may ilang mga mangyan din ang tumugon sa paanyaya ni Father.

Sa marami niyang balak ipagawa kinailangan niyang pumunta sa Germany upang humingi ng tulong sa kanyang mga kaibigan at mga benefactors. Hindi naman siya nabigo. Hindi lahat na nagbibigay ay mayayaman, subalit marami ang regular na >>> pahina 11

La Brisa sisimulan na, lalabanan ng "tenants"

Sisimulan na sa Oktubre ang La Brisa Del Mar, isang subdivision na itatayo sa mahigit na 16 na hektaryang lupa na napapaloob sa Bagong Pook at Aguada sa may Poblacion. Nabili ng La Brisa ang 14 na hektaryang lupa sa PNB na nagsubasta ng lupa matapos maremata nila ito sa dating may-ari, ang pamilya Chua.

Kaugnay nito, mahigit na 200 pamilya na nakatira sa loob ng lupain ng La Brisa ang sinabihan na lumikas na. Ang La Brisa ay nag-alok ng 2 bagay sa kanilang mga "tenants" upang likasin ang lupa: halagang 2,000 pesos o kaya ay lupa sa sigayan na kung saan pede silang lumipat. Kung lilipat sila sa 1 hektaryang lupa sa Sigayan ng La Brisa, 2 taon raw ang libre na renta at pagkatapos nito pede

Sisimulan na sa Oktubre ang La rin nilang bilihin ng "installment" ang sa Del Mar, isang subdivision na lupa.

Subalit, marami sa nakatira ang nagsabing lalabanan nila ang planong relokasyon. Anila, meron sila mga dokumento na nagpapatunay na nabili nila ang mga lupa na kung saan nakatirik ang mga bahay nila.

Sinabi ng La Brisa na nagrereklamo ang mga nakatira sa may Aguada na sila di-umano ay nagbayad sa pamilya Candava sa lupang kinatitirikan nila ngayon. Dagdag ng La Brisa na ang pamilya Candava ang dating me-ari ng lupa subalit ito raw ay napunta sa mga Chua at pagpakatapos ay napunta sa PNB. Sinabi ng La Brisa na nanalo ang PNB sa isang kaso laban sa mga Candava na nagpapatunay na PNB ang talagang me-ari ng lupa.

Plano ng La Brisa na makipagugnayan sa mga apektadong pamilya at sa mga lokal na opisyales upang maging maayos ang relokasyon ng mga tenants.

Sa isang panayam, ibinunyag ng La Brisa na magtatayo sila ng isang "first class" na subdivision, na kung saan ang malaking bahagi ay mapupunta sa sona na Agro-residential - magkasamang taniman at bahay. Mga 18% ang para sa residential at me bahagi din na commercial.

Ani La Brisa sa mga tenants nila:"Gusto namin pare-pareho panalo. Happy kami at happy din sila."

Subalit ngayon pa lang ay marami sa mga tenants nila ang nagsabi na lalabanan nila ang planong relokasyon. Anila: "Meron kami karapatan dito."

Tutol si Vice sa proyekto ni Mayor

Ed: Sa pambihirang pagkakataon, bumaba si Vice Mayor Teo Atienza bilang Presiding Officer ng Sangguniang Bayan para magtalumpati sa Regular Session noong July 14. Ito ang nilalaman ng kanyang Privilege Speech tungkol sa mga proyekto ng administrasyon.

Bilang isang lingkod-bayan na naglingkod isang termino bilang Pangalawang Punong-Bayan noong 1995-1998 at naglingkod ng tatlong termino bilang Punong-Bayan simula 1998-2007 at ngayon ay kasalukuyang naglilingkod bilang Pangalawang Punong-Bayan. Sa mahabahaba ko rin paglilingkod ay totoong napamahal na sa akin ang bayang ito.

Tungkol sa issue na ating pinagtatalakayan, Resolution No. 2008-116 "A Resolution Authorizing Hon. Hubbert Dolor, Municipal Mayor To Enter Into Loan Negotiation With The Landbank Of The Philippines In Connection With The Proposed Renovation Of The Municipal Hall, Conven-

tion Center And The Low-cost Dormitory In The Public Market Building And Municipal Gymnasium (Aircon) And Purchase Of Heavy Equipments And Vehicles For The SB Members Use".

Kung bubuksan natin ang section 296 of the Local Government Code, it lays down the two parameters of credit financing on government indebtedness:

First, the expenditure must pertain to local infrastructure and other socio-economic development programs;

Second, the same must be in accordance with the approved local development plan and public investment program.

Sa resolution na hinihingi ng ating magaling at matalinong Punong-Bayan na bigyan siya ng Authorization upang makipagnegotiate sa Land Bank of the Philippines para sa mga sumusunod:

a) Ang pag renovate ng municipal hall - Maganda nga po pero kasama ba ito sa sinasabi ng Section 296? Bakit kailangan na bang i-renovate ito? Kayo na po ang sumagot?

b) Convention Center - Balikan natin ang nakaraan, nagtayo si Mr. Padilla ng masasabi nating isang Convention Hall na naglalaman ng 500 or more participants, pero anong nangyari? Kayo na rin po ang sumagot. Ang Yokota Club ay ganun din ang malungkot na nangyari.

c) Low-Cost Dormitory - Sa inyo bang sariling pagpapasiya akma ba sa sinasabing lugar ang proyekto na yon? Kayo na po ang magisip ng kasagutan.

d) Municipal Gymnasium (air-conditioning) - Sa yari po ng ating gymnasium ay hindi kailangan lagyan ng aircon, bakit? Hindi po akma sa kayarian at napakamahal po ng magiging gastos sa kuryente. Problema sa kasalukuyan ang mahal na fuel (diesel, gasoline, at iba pa). Kailangankailangan ba itong malagyan ng aircon?
